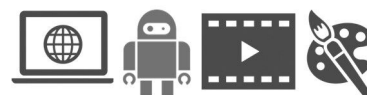

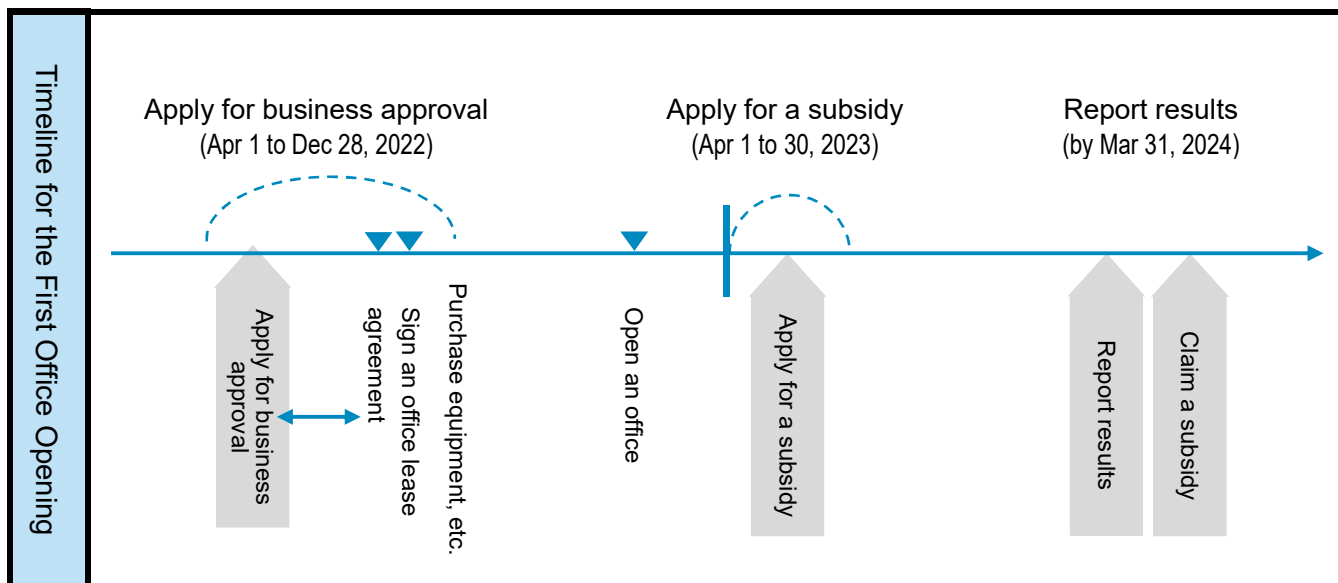


2022 City of Nagoya Subsidy Program for Promoting Clusters of ICT and Other Companies

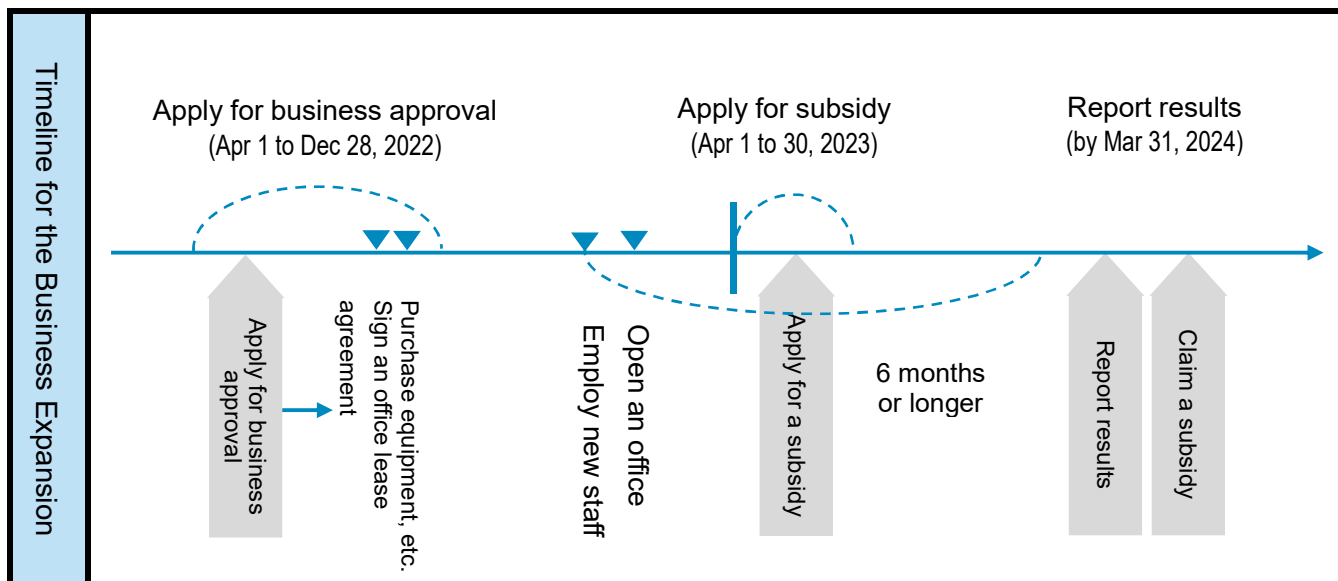
This program provides subsidies to ICT and other companies to help with costs for opening their first office in the city, or with costs for expanding their business in the city in case of a company that has already had an office in the city.

Eligible Industries	<div>(1) ICT Information services, internet-related services</div> <div>(2) Robots Robot manufacturing</div> <div>(3) Digital contents Film & video production, TV program production, animation production, film, video & TV program distribution</div> <div>(4) Creative Design</div> <div>* In principle, companies that were founded three or more years ago</div>	
Types of Subsidies	First Office Opening	Business Expansion
Eligible Applicants	Companies that are planning to open their first office in Nagoya	Companies that opened their first office in Nagoya within the last 5 years
Other Requirements	<div>· Floor space of 30m² or more</div> <div>· Two or more engineers and/or the like permanently stationed at the office opening</div>	<div>· Increase its floor space by 30m² or more to expand its business</div> <div>· Employ two or more new full-time engineers and/or the like</div> <div>· Invest 3 million yen or more in equipment, etc.</div>
Eligible Costs	<div>50% of the annual rent</div> <div>50% of the costs for purchasing equipment, etc.</div>	<div>50% of the annual rent</div> <div>50% of the costs for purchasing equipment, etc.</div> <div>1 million yen per new full-time employee</div>
Maximum Subsidy Amount	5 million yen	10 million yen
Application Deadline	One day before the day on which an office lease agreement is signed or equipment, etc. are purchased, whichever comes earlier	

■ Timeline



- In principle, an office must be opened within a year from the business approval application date. If not, the approval shall be canceled.
- Costs for purchasing equipment, etc. shall be eligible for a subsidy when the purchase dates fall within the same fiscal year during which a business approval application is submitted.



- 1 million yen per new full-time employee shall be awarded when it can be confirmed that he or she has been employed for at least six consecutive months from the business approval application submission date to the results report submission date.
